From the President:

It has been a year highlighted by proposed MassHealth regulations (yet to be promulgated), and tireless advocacy by so many of our members relative to the same under the guidance of our lobbyist, Nomita Ganguly. Through these efforts and countless meetings across the Commonwealth, we have forged new relationships with our legislators (Representatives and Senators alike). We have had the privilege through these meetings and those with the Secretaries of Elder Affairs and Health and Human Services to showcase what we, as elder and disability lawyers are really about – advocating for those in need who require dignity and compassion and ethical counsel during difficult and emotional times. The message being that we are partners in this process.

Featured Board of Hearings Decision:

IRREVOCABLE INCOME ONLY TRUST (FAVORABLE)

[Board of Hearings Appeal Number 1615178, November 30, 2017](#)

MassHealth denied the appellant's application for MassHealth long-term care benefits because of excess assets. At issue was a trust containing real estate. MassHealth argued that the trust was countable because the appellant's right to use and occupancy entitled the appellant to fair market value rental income from the property. MassHealth also argued that accumulated income in the trust becomes principal in the month after it is received. The Appellant argued that the right to use and occupy property in trust is not a countable asset but rather an income interest. The Board of Hearings approved the appeal, finding that the imputed value of rental income should not be converted into an asset for eligibility purposes. Also accumulated income cannot be distributed to the appellant under federal law, MassHealth regulations and the terms of the trust.

Member's Note on the Affordable Care Act:

The Affordable Care Act mandates that MassHealth must apply the spousal minimum monthly maintenance needs allowance (MMMNA) applicable to nursing home based applicants to community-based applicants as well. This means that the husband and wife who apply for the frail-elder waiver program are entitled more than simply the standard \$500.00 per month for support that MassHealth has allowed. The relevant section of the law is PL 111-148, Sec. 2404. MassHealth is not presently allocating income in this fashion.

The Standing Order establishes a Fiduciary Litigation Session to be held in the Norfolk Division of the Probate and Family Court for a pilot period of one year. The Honorable Elaine M.
